# Budgeting, Planning, and Cost Control

## Introduction

In this Budgeting, Planning and Cost Control course, participants will learn the process of budgeting as a management tool to plan and control its business activities and to attain the desired results.

A carefully prepared budget allows management to evaluate company performance. It serves as the standard against which the actual performance is compared.

By analyzing the variance between actual and budgeted results, a budget can provide a “red flag” when a business is not doing well, and it can direct attention to areas where actions may be needed.

Additionally, variance analysis can indicate opportunities not initially predicted in the budgeting process or reveal that the original budget is unrealistic in some way.

After attending this course, participants will:

1. Understand the processes of budgeting, planning and cost control.
2. Know how to develop strategic plans and budgets.
3. Be able to evaluate company performance using variance analysis.
